URBANS 2006 Annual Report to NHLA

Members of the Urban Libraries Section of New Hampshire Library Association are libraries in the state serving a population of at least 18,001 and are certified libraries as defined by the standards established by the New Hampshire State Library. The top two administrative positions in the member libraries are eligible to represent the libraries at Urbans meetings.

The organization's objectives are:

1. To provide increased communication and information exchange among urban public library administrators.
2. To promote mutual understanding of library issues and problems statewide and nationally, and to address those issues.
3. To promote the marketing of the library as a resource for community development and civic infrastructure.
4. To achieve operational economies through cooperation.
5. To encourage development of professional management and leadership skills, and to apply those skills to librarianship.

NHLA FALL CONFERENCE WRAP-UP

The NHLA Annual Fall Meeting and Conference was held on Thursday, November 2nd at the Capitol Center for the Arts (CCA) in Concord, NH. It was a rainy, gray day. It was awkward to unload the registration materials and keep an umbrella overhead, but as I approached the CCA the day brightened as I saw the marquis. It read: “*NH Library Assoc. - Fall Conference - Library Outreach.*” Right out on Main Street, in downtown Concord, NHLA was on display. I continued with a smile until I got inside the building to discover that there was no power – the space was dimly lit by emergency lighting but overall it was dark. The CCA staff was working with the utility company to solve the problem, and by the time I finished unloading the car, the lights were on and the facility was ready to go a full forty-five minutes before the conference was to begin.

I thought to myself if this is how we start the day then things can only get better from here and I was NOT wrong. More than 100 librarians from around the state attended, and the agenda was a full one. The morning began with a panel presentation from our own Intellectual Freedom Committee (IFC). Members provided tips for talking to the press, and two folks from the press were on hand to answer questions and provide another perspective. In the second session, the New Hampshire Humanities Council (NHHC) introduced some new initiatives and spoke about the myriad opportunities available to NH libraries. The morning ended with a treat - Chautauqua scholar, Barbara Miles, introduced us to Ruth Law, New Hampshire’s celebrated

female aviator. It was an entertaining journey back through time and an enthusiastic performance that brought to life this feisty, independent woman.

The afternoon sessions were sponsored by the New Hampshire College and University Council (NHCUC) Libraries Committee. The keynote speaker, Steven M. Cohen, is the creator of *Library Stuff* (<http://www.librarystuff.net>) a weblog dedicated to current and professional development for librarians. He has also been the contributing editor of the Internet Spotlight column for *Public Libraries* since 2001. His presentation focused on creating and implementing blogs and RSS feeds. It was a lively session and if you missed it, Steve provided a web link to his outline – check it out at <http://stevenmcohen.pbwiki.com/NHLA2006>. The final session of the day was a “Best Practices” panel made up of academic and public librarians sharing their innovative ways to reach patrons through technology.

This one-day annual meeting/conference format is a great opportunity for professional development and social networking with colleagues. I enjoyed putting the day together and I am grateful to the folks who stepped up to help out. I am marking my calendar for November 1, 2007 when Amy Thurber, our recently elected Vice-President and her committee, will offer the next annual NHLA Fall Meeting and Conference. You should pencil-in the date, you don’t want to miss out on a great time!

NHLA has been the best place to be in touch with your colleagues since 1889. In this spirit, we have created 21st century methods of communication: a blog and a wiki.
